## MEMBERSHIP AGREEMENT

**Members will be subject to all Club Rules and Regulations as identified below:**

1. Members will be responsible for damage to any property of the Club, caused by Member or Members family, guests or invitees.
2. Use of the Club facilities is at the sole risk of the member, and member waives any claim for loss or damage to Members property in connection with Members use of the facilities.
3. Member agrees to hold the Club harmless for any and all injuries incurred while on the Club property.
4. Membership fees are not refundable and membership privileges are not assignable, unless approved by the Club.
5. Member acknowledges that an annual membership is not an investment in the Club. Annual Dues are pre-paid user fees, and does not create or convey a legal equitable property interest of any kind, nature, right or description whatsoever in either the Club or the Club facilities.
6. Member acknowledges that Huntmore Golf Club is sole owner of the Club and all related facilities with the sole right to operate the Club and such facilities. These rights include but are not limited to:
  - a. The right to change or discontinue operation of the Club facilities.
  - b. The right to discontinue memberships or pre-paid green fee programs
  - c. The right to exercise any and all other rights of ownership including the right of sale to others.
7. Members are expected to be supportive of the facility and be respectful to the staff. Members who violate this policy will be subject to termination or non-renewal at the sole discretion of Huntmore Golf Club.
8. Membership privileges may also be revoked by the Club for violation of the Clubs rules and regulations.
9. Presentation of a membership card may be required upon check-in each time while using the course or practice range.
10. **No personal coolers or carry on alcoholic beverages will be permitted.**
11. Annual Memberships expire on the day the course closes at the end of the golf season unless otherwise extended by the Club, or terminated for violation of the Clubs rules and regulations. Any membership renewal is subject to approval by the Club at its sole discretion.
12. All facilities, equipment, hours, prices, services, rules, regulations and policies of the Club are subject to change at the sole discretion of the Club.
13. Member acknowledges that the entire property or a portion thereof known as Huntmore Golf Club may be closed from time to time at the discretion of the Club for special events and/or routine or maintenance and repairs. Such events or routine maintenance and repairs will not cause the Member to receive any additional consideration or reimbursement for the lost time and opportunity.

Membership in the Club will be governed by the above terms, conditions, and the Club rules and regulations. The Club at its sole discretion will determine such terms, conditions, rules and regulations, fees charged and the cost of any membership or the number of memberships available.

Ownership of a home within the Huntmore community (Huntmore Estates) confers no membership rights upon the owner of such home, nor any right to make application for membership, nor any right to make use of the golf course or other related facilities, nor the use of a private golf cart upon Club property.
